## Deals Gap Part 2

With the Great Smoky Mountains National Park (GSMNP) lying along the northeast side of U. S. Highway 129 and along the northwest side of parts of North Carolina Highway 28, the selection of a portal into the National Park for the Benton MacKaye Trail (BMT) should have been easy. It was not. The old pre-1948 route of the Appalachian Trail (AT) from Tapoco on the Little Tennessee River to Doe Knob was used as the baseline for planning. There would be a point where the BMT would leave the state line, cross over the AT, and descend into the wilds along the North Carolina side of the park.

Of particular interest within the GSMNP were the bald summits of Parsons Bald and Gregory Bald straddling the Tennessee – North Carolina state line. These mountaintops held expansive views of the western end of the park. One could look right down the spine of the Smokies all the way to Clingman's Dome. Fontana Lake was in view to the right. Cade's Cove was in view to the left. A panoramic camera view could catch them all in one frame. The existing trail that continued out to Doe Knob would leave the BMT in a situation where co-alignment was necessary with the AT. There was not a direct crossing of the AT at Doe Knob, so a turn south to Sassafras Gap or a continuation east to Spence Field would be required before a side trail leading into North Carolina would be available. Another option to make the long descent of Long Hungry Ridge Trail down to Twentymile Creek was shown on some early plans. But all these options depended on entering the park at Deals Gap.



The National Park Service made known their dislike of a Deals Gap entrance into the park early and often. Based on their experience with vandalism and other unmanageable situations at Davenport Gap on the eastern edge of the park, they predicted Deals Gap would become "Davenport Gap West" if a trailhead were opened there. Of concern in the west end of the park was the problem of poaching, particularly of the bear population. These problems were echoed during an impromptu meeting at park headquarters on May 15, 1992.



If the BMT were to run through the park, the Park Service would insist on a more secure entrance at the Twentymile Ranger Station on Highway 28. Even with the success on the south side of Deals Gap, this would mean walking 0.7 mile along the busy U. S. Highway 129 and 2.8 miles along North Carolina Highway 28. A few Benton MacKaye Trail Association (BMTA) members were well versed on the history of the area and did some research into an abandoned highway – North Carolina Highway 288. This predecessor of Highway 28 had run north of the Little Tennessee River from Bryson City to Deals Gap in the era before Fontana Lake was created. In fact, part of the BMT north of Fontana Dam follows part of this roadway, although other parts are now under water. The far western portion at Deals Gap was gated. When BMTA members inquired about the ownership status, the North Carolina Department of Transportation couldn't even find any record of it. Research a little closer to home revealed that the old road was split down the middle with the GSMNP owning one half and the private ownerships on the south side owning the other. The Park Service had no authority to open the roadway to public use and the multiple private owners had no interest in public use of the road as a trail.

Had permission been obtained to use the old road, the BMT could have simply crossed Highway 129 in Deals Gap and been separated from the vehicular traffic all the way to within a half mile of Twentymile Ranger Station.

As it was, the trail followed the increasingly treacherous road walk along Highways 129 and 28 from Deals Gap to Twentymile Creek until the Yellow Creek Mountain relocation was instituted in 2014. A route over Parsons Bald and Gregory Bald was still possible, but not terribly practical, from Twentymile Creek. Using the circuitous 12.1-mile combination of the Wolf Ridge Trail, Gregory Bald Trail, and the Long Hungry Ridge Trail, the trail could have left Twentymile Creek Trail and returned to it 2.6 miles further upstream. Nobody in the BMTA ever proposed this, and it is doubtful if the Park Service would ever have approved it.

With the completion of the BMT from Cheoah Dam to Deals Gap, hikers tolerated the road walk along Highway 129 and Highway 28 to Twentymile Ranger Station. There was very little road shoulder upon which they could seek refuge, but at least the traffic was sparse. This condition did not last long. Beyond the year 2000, motorcycle riders and sports car owners "discovered" Highway 129 and promoted it as a challenging adventure on which to test their rides. Savvy promoters saddled the road with the moniker "Tale of the Dragon". In no time, the popularity of the highway skyrocketed. While this was good for the handful of businesses in the area, the BMTA had to look at alternatives to Deals Gap.



As early as 2011, there were independent proposals to rehabilitate the Yellow Creek Mountain Trail from Tapoco to its intersection with the AT south of Fontana Village.

The general idea was to promote a well-maintained third trail connected to both the AT and the BMT that could provide an opportunity for a two- or three-day loop hike. The Forest Service was far too involved in other matters to consider it at the time, but with consistent pressure from the BMTA, a proposal to move the BMT onto the Yellow Creek Mountain Trail eventually was approved. This was largely spearheaded by Dick Evans and Ernest Engman, and on May 30, 2014, the BMT was officially relocated to Yellow Creek Mountain, the Fontana Village Trails, and Fontana Dam via the AT.

The first guidebook update after the relocation retained information on the old route in addition to the description for the relocation. However, the old route using Twentymile Trail and Lost Cove Trail as shown on the National Park Service's GSMNP trail map were gone. The gold highlight for the BMT now ran from Fontana Dam to Lakeshore Drive (Road to Nowhere) almost entirely on the Lakeshore Trail.





Today, gems of this trail route reflect the vision and hard work of the BMTA.

## Forest Fun, A Stroll through the Seasons with Suzy

## **GA Maintenance on Fall Branch Falls**

The monthly Georgia maintenance trip on September 14, tackled Section 6b leading to Fall Branch Falls. The BMTA, at the request of the Forest Service, had rerouted the original trail to protect the stream from siltation. The Falls is an extremely popular destination for locals as well as area visitors. The trail was showing signs of stress, particularly due to the use of short cuts, rather than the designated trail.

To no avail, the Forest Service had previously placed signs asking people to stay on the trail. On this trip, two crews were assigned the task of barricading these trails with downed tree debris. Steve Hayden led Crew One, consisting of David Ensley, Darcy Douglas and Dave Ricker. Kenny and Daphne Martin, Laurie Schatz and Tim and Sage Elmore formed Crew Two. They cut, carried, dragged and piled debris to block six short cuts. This work will be closely monitored to determine if it sends the message to "Stay on the Trail".

Ian Guttridge led the team of Steve Pruett and Gilbert Treadwell to replace two decaying steps leading to the falls. On their way back to the parking area they trimmed multiple trip hazards within the heavily worn trail. Andy Meeks, Will Stanley, Steve Dennison, Joe Cantwell and first time BMT maintainer Stephen Catana (welcome!) regraded 22 water diversions between the Falls and the Stanley Creek Trail intersection. Ed Sullivan led the fifth crew of Art Kolberg and Bob Cowdrick to Section 3a between Hwy 60 and the Wallahala Overlook. Their day was occupied with shaping 22 water diversions and removing one tree.

As the Maintenance Director, I am extremely pleased with the results of 20 volunteers, dedicating 119.5 hours on a Saturday, keeping safety as a priority and working to keep the BMT in outstanding condition.

# Clingman's Dome Name Restored to Kuwohi

The U.S. Board of Geographic Names has approved the Eastern Band of Cherokee Indians request to restore the mountain's name to its Cherokee name. The name Kuwohi (pronounced koo-WHOA-hee) in Cherokee means "mulberry place".

Kuwohi is the highest point in the Smokies and is a sacred mountain to the Cherokee.

Efforts to restore the Cherokee name began in 2022 by the Eastern Band of the Cherokee members Lavita Hill and Mary Crowe.







